The company will offer the whole range of CNIM and MARTIN expertise in the design, construction and delivery of turnkey energy-from-waste and biomass plants, combustion and flue gas treatment technologies, revamping services aiming at improving energy and environmental performance.

It has also delivered almost 300 biomass-to-energy facilities and more than 400 flue-gas treatment systems. CNIM also operates 13 waste and biomass treatment sites, including 9 in France.
