This sector includes **CNIM Industrial Systems Division** and **Bertin Technologies**, whose skills and resources are deployed in close synergy.


CNIM Industrial Systems Division includes CNIM Industrial Systems, CNIM China, CNIM Singapore and CNIM Air Space.
